

**Subject: Ex article 13D.LGS. 196/2003**

We would like to inform you that the Italian D.Lgs. n.196 dated 30/06/2003 (Italian civil code for personal data) implies the ward of people and other persons relative to the treatment of personal data.

Therefore, in accordance with art.13 of D.lgs. n. 196/2003, we would like to inform you of the following:

1. Your personal data will be treated only for administrative, counting and fiscal aims and, in general, for the fulfilment of the duties of the law and of the present and future contract/s.

2. The treatment will be done with the use of computerized support and paper archives which may guarantee safe and privacy, in respect of the above mentioned law and of the relative duties and in accordance with the aims and procedures illustrated in the law.

3. Conferment of data is compulsory and the eventual refusal implies the impossibility of fulfilment of duties and resulting from the contract/s with the further consequence that the it/they cannot be concluded. Therefore, even during the execution of the contract/s, the request of cancellation of data necessary for the execution of duties derived from the contract/s of the law, that is the refusal to their conferment, implies the impossibility of continuing the relation.

4.Data can be communicated to the following figures:

- a) Responsible for treatment of personal data for the fulfilment of duties which derive from the contract/s, present and future and from the law;
- b)those who are authorized to make operations of treatment by the Holder or by the responsible for the fulfilment of the duties which derive from the contract/s, present, future and from the law;
- c) entity which is competent for the fulfilment of eventual duties of law in tax and providence matter;
- d) banks or credit institutes for money transactions;
- e) insurance companies selected by the Holder for insurance aims;
- f) consultants or free professionals, singles or associated;
- g) physical or juridical persons who provide specific working services or linked activities, instrumental or which support those made by the writing.
- h) other people who make operations of treatment on behalf of the Holder.

5. The Holder of the treatment is Blue Magic Srl, Via Grotte di Nottola snc, 04012 Cisterna di Latina (LT).

6.The Responsible of the treatment is the engineer Cinzia Coppola.

We inform you that any further information, even related to eventual changes of the holder or responsible, will be announced through a communication on the web-site [www.bluemagic.it](http://www.bluemagic.it).

7. In every moment you can exercise your rights towards the holder of the treatment, in accordance with art.7 of D.lgs. 196/2003, that we here fully reproduce:

1.The interested part has the right to obtain confirmation of the existence or not of personal data which deal to him/her, even if not already registered, and their communication in a clear way.

2. The interested part has the right to obtain:

- a) origin of personal data;
- b) aims and ways of treatment;
- c) logic applied in case of treatment made with computerized support;
- d) coordinates of the Holder, of the Responsibles and of the Representative chosen in accordant with art.5 (comma 2);
- e) people or categories to whom personal data may be communicated or those who can get informed as representative chosen in the country, of responsible or delegates

3.The interested part has the right to obtain:

- a) update, rectification and, when interested, integration of data;
- b) cancellation, transformation in anonymous form or stop for data treated against law, included those for which it is not necessary the conservation in relation to the aims for which data have been collected or afterwards treated;
- c) attestation that the operations (a)(b)have been spread, even for their content, for those to whom data have been communicated or spread, except the case in which this fulfilment is impossible or implies too many investments.

4.The interested part may oppose resistance to:

- a) the treatment of personal data, related to the aim of the collection, for legal reasons;
- b) the treatment of personal data for delivery of advertising or direct sale or for market research or trade communication.

Please note that , in accordance with art.24 of D.legs n.196/2003, is not necessary your consensus to the treatment of data you gave and necessary for the fulfilment of duties which derive from the law and from the present and future contract/s.
